PUBLIC NOTICE

The National Land Commission is established under Article 67 of the Constitution of Kenya 2010. Its functions include managing public land on behalf of the National and County Governments. Section 14 of the National Land Commission Act mandates the Commission to, on its own motion or upon a complaint by the National or County Government, Community or an individual, review all grants and dispositions (titles) to public land to establish their propriety or legality.

Notice is hereby given that owners of the listed parcels of land situated in Shella and Kipungani areas of Lamu island in Lamu county are required to appear before the Commission to show cause why these allocations should not be revoked on the grounds that their allocations violate Articles 42(a); 60(1) c; 66(1); 69(g) and 69(2) of the Constitution of Kenya, and further that they contradict Sections 11(1); 11(3) of the Land Act of 2012, and also Section 12(2) of the same Act, and other statutes contained in the Forest Act, Water Act, EMCA of 1996.

- 1) Letters of Allotment
- 2) Minutes approving allocation
- 3) Copy of PDP
- 4) Copy of a Deed Plan
- 5) Copy of the Title
- 6) All correspondence touching on each of the above documents

Take note that failure to appear before the NLC or failure to justify the allocations shall leave the Commission with the only option of revoking the said titles in order to protect the water reservoirs of Lamu Island.
